OFFICE MEMORENDUM

To expedite the progress of work under R-APDRP Part-B and RGGVY-11th & 12th Plan schemes, the list of approved vendors of PVVNL is being uploaded on the website of PVVNL. In this regard the following is hereby directed:-

1. No separate approval shall be required if turnkey contractors select vendors from approved list of PVVNL and other Discoms of Uttar Pradesh.
2. The vendor must not have been black listed or debarred by any utility or Government organization on the date of approval.
3. For major items namely Transformer, Cable, VCB, Conductor and Meter, any vendor who has been supplying similar material or of higher size/rating to any other power utility of the country and to the Government department of Uttar Pradesh for at least three years, may be treated as approved vendor subject to the condition that the vendor is having valid type test report issued within five years from CPRI conforming to PVVNL/UPPCL specifications. In case the firm has type test report from labs other than CPRI, the firm will have to submit an undertaking to submit type test report from CPRI within three months. Then the firm shall be approved as vendor with the condition that the firm submits type test report from CPRI within three months failing which approval may be withdrawn. In such cases, material from the firm will be accepted but payment to the turnkey contractor for such material will be made only after receiving valid type test report from CPRI.
4. For other items which are not available in the above list, any vendor who has been supplying similar material or of higher size/rating to any other power utility of the country and to the Government department of Uttar Pradesh for at least one year, may be treated as approved vendor subject to the condition that the vendor is having valid type test report issued within five years from CPRI/ERDA or NABAL accredited lab in conformity with the technical specifications of PVVNL.
5. The GTP & Drawings of such vendors will be approved in light of the technical specifications of PVVNL and only after submission of valid type test report.
6. The nos. of GTP & Drawings approved for one contract should normally be restricted to 4 Nos. for all the items except PCC poles & transformers, in which case it may be 20 Nos. & 10 Nos. respectively.
7. All the turnkey contractors are hereby given 30 days time to submit balance GTP & drawings for approval in conformity to clause No. (1) to (4) above.

The above order will come into force with immediate effect.


