**2. Terms and condition of nominated members –**

- A.** The nominated member shall have a term of three years. Provided that such nominated member shall be eligible for one-time reappointment for a second term of three years either in the same forum or in the forums, which are placed vertically above in the hierarchy of the forums. Provided further that no nominated member shall hold post as such after he has attained the age of 70 years.
- B.** The members nominated by the distribution licensee and the commission shall be paid remuneration by the licensees on per sitting basis as specified in point-3. The remuneration shall be in accordance with the orders issued by the Commission from time to time.
- C.** Any nominated member may relinquish his office by giving three months’ prior notice in writing to the distribution licensee/commission as the case may be.
