 2. Tenders are to be submitted in 2 Parts which shall be uploaded on e-tender web portal www.etender.up.nic.in up to 10: hrs. On the scheduled date of opening of the tender.
 3. **The Part –I (Tender Cost +EMD) and (Techno-commercial):-**
Tender Cost +EMD: The tender cost & EMD will have to be deposited on-line through RTGS/NEFT in PNB Bank, Account No. 3947002100010951 of EX. EN. Electricity Civil Distribution Division Ghaziabad, IFSC Code no. PUNB0394700. Techno-commercial: Each and every page of the tender documents submitted in this part in support of fulfilling the Pre-qualifying requirement, should be duly signed, Stamped & scanned. PRE-QUALIFYING CONDITIONS FOR TENDERERS (PQR)

Technical & Financial Pre Qualifications :-

The Tenderer must fulfill the following technical /financial requirements -

1. The tenderer should produce experience statement showing the Name of organization, name of work, DOS, DOC, ADC, Agreement Value, Executed Value, Penalty and experience of officer with contractor during the execution of work executed in Central/State Govt. Depts. and that should not be issued by officer below class-I rank (shall be produced in Part-I).
2. Tendering firm should have experience of having successfully completed similar nature works during last 7 years ending last day of month previous to one in which applications are invited and should be either of the following (shall be produced in Part-I):-
 - A. Three similar* completed works each costing not less than the amount equal to 40% of the estimated cost. or
 - B. Two similar* completed works each costing not less than the amount equal to 50% of the estimated cost. or
 - C. One similar* completed work costing not less than the amount equal to 80% of the estimated cost.

Similar nature work means:-

3. Average Annual financial turn over during the last 3 years ending 31st March of the previous financial year, should be at least 30% of the estimated cost for which practicing C.A. approved Turn Over Certificate has to be submitted (shall be produced in Part-I).
4. ITR of Last 3 Years Shall be Submitted by the Contractor (2019-20, 2020-21 & 2021-22).
5. The tenderer should submit the following certificates in Part-I in readable form and duly signed otherwise may result in rejection of bid.
 - A- Certified & self attested copy of UTR No. & other detail for tender cost & earnest money.
 - B- Valid character certificate issued by D.M/S.P, for partnership firm and Pvt Ltd firm Character certificate of All Directors shall be submitted. Character certificate shall be valid on date of opening of Part-1 of tender.
(Tenderers should submit on rupees 10 Non-Judicial Stamp Paper an affidavit (Duly Notarized) in favor of S.E., ECDC GZB in given format.)
 - C- GST Registration copy.
 - D- PAN Card Copy.
 - E- Experience certificate as stated S.No.1 &2.
 - F- Annual financial turnover of the last 3 year sending 31st March of the previous financial year duly issued by practicing C.A. with UDIN No.
 - G- Partnership deed in case of partnership firms.
 - H- Copy of Adhar Card.
