## **GENERAL TERMS & CONDITIONS :**

### **Responsibilities of Contractor:-**

1. The contractor is required to make they fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
2. The contractor shall be supplying, erecting, testing & commissioning of all materials and equipments not mentioned specifically in the scope of works but required to complete the job in all respect, except excluded specifically for which no extra payment shall be made.
3. The Contractor shall have to arrange all carriage facility including transportation cartages, man power, T&P etc.
4. Any type of NOC for the completion of following work will be arranged by the bidder itself only, Department will not be liable for these NOC.
5. Illumination/Lighting of working site shall be in the scope of contractor. Nothing shall be paid by the PVVNL.
6. Safety of Man & Material shall be ensured by contractor.
7. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.
8. Contractor shall have to deposit a security Amount @ 10% of the value of Awarded Contract in the form of FDR/PBG pledged in favor of SE EUDC-2 NOIDA and shall be returned/refunded after work completion/NOC by Concerned division.

### **Taxes:-**

GST will be paid extra as per rule.

### **Others Terms & Conditions:-**

- 1- The charges for Road cutting, Forest Clearances charges, land lease charges or from any other agency which are required to complete the work shall be paid by the contractor, except other than items mentioned in BOQ.
- 2- Any loss or damage to any of the public utilities shall be repaired by the contractor at his own cost.
- 3- The Contractor shall have to arrange all carriage facility including transportation cartages, man power T&P etc on its own cost except other than carriage mentioned in BOQ.
- 4- The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/ Loss/Accident etc of any kind and Damaged and Removed material and Spares parts will be retained by department.
- 5- No T&P will be provided by the department. The Contractor shall arrange all the T&Ps. Equipments. Welding set, generator set etc. required for carrying out the above work at his own cost.
- 6- The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts /damages/accidents etc. to the material of the PVVNL.
- 7- During the period of work in progress, the Contractor shall have to provide lighting arrangement sign board etc or necessary precautionary arrangement so that accident/ damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
- 8- The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt/ PVVNL.

- 9- All the charges on account of damages/losses/thefts etc. involved under the condition laid down above shall be borne by the contractor.
- 10- Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc.
- 11- The contractor shall have to execute the work within the stipulated time as provided in the order issued by the competent authority.
- 12- A Penalty @0.5% per day for Delay/Late in Execution of work shall be payable by the contractor on the total value of contract. The maximum penalty livable will not, however, exceed 10% of the value of the order not execution.
- 14- The Proper Shut down will be given as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
- 16- The work is to be done by the Contractor under the Direct Supervision of Nodal S.D.O (Dist.).
- 17- Quantity under scope of work may vary up to any extent but the face value of the Agreement shall not vary beyond the (+/-) 10% within the financial approval Limit after prior permission of contract of Engineer.
- 18- General Conditions of Contract Form 'A' & Form 'B' and Standard Contract Conditions of UPSEB/ UPPCL/PVVNL/SE EUDC 2 Noida shall be integral part of tender specification.
- 19- All the spare parts required to be replaced/repared/provided by the contractor under 12 month warranty period.
- 20- Income Tax and Labour Cess shall be deducted from the bills of the Contractor as per rules prevailing of Central Govt. at the time of payment.
- 21- If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL of the Contractor.
- 22- The material shall be PVVNL GTP approved and inspected by the department at manufacturer works unit before supply.
- 23- The contractor will purchase the material as per PVVNL Approved GTP and RESPO.
- 24- The supplier of the material shall have the experience of supplying the material to PVVNL/ Govt. / PSU utilities.
- 25- Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
- 26- The Agreement can be terminated by the Engineer of the Contract at any time without any notice in the event of un-satisfactory performance of the Contractor. This is however, without prejudice to the other Terms & Conditions of the Agreement.
- 27- Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/PVVNL shall not be liable for any such compensation etc.
- 28- For repairing and overhauling of all the spare parts required to be replaced/repared will be provided by the contractor and the entire repairing/overhauling work shall be carried



- out the site. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions.
- 30- Any damage or loss of public property/Board's materials shall have to be borne by the contractor.
- 32- The contractor will purchase the material as per PVVNL approved GTP/technical specification. The Final GTP of the material will be approved by the S.E., EUDC-2, Noida before commencement of Supply.
- 33- Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
- 34- The Agreement can be terminated by the Engineer of the Contract at any time without any notice in the event of un-satisfactory performance of the Contractor. This is however, without prejudice to the other Terms & Conditions of the Agreement.
