1. **RATES:-** The rates mentioned in the schedule of quantities and prices are shall be firm.
2. **PAYMENT:-** 100% Running payment shall be allowed against the work done and verified by the Engineer-in-charge of the work done and verified by the Engineer-in-charge of the work, through cheque on availability of funds.
3. **CANCELLATION OF TENDER:-** Superintending Engineer,EDC-I,MZN have right reserved to any change/cancellation of tender in Corporation Interest without assigning any reason what-so-ever.
