## **PRE QUALIFICATION REQUIREMENTS (PQR) FOR THE BID**

### **For Tender no 116/21-22**

Qualification of bidder will be based on meeting the minimum pass/fail criteria specified in Part-A below regarding the Bidder's technical experience, requirements and financial position as demonstrated by the Bidder's responses in the corresponding Bid Schedules.

The bidder shall also be required to furnish the information specified in Part-B in their Bid. Subcontractors' technical experience and financial resources shall not be taken into account in determining the Bidder's compliance with the qualifying criteria.

Notwithstanding anything stated herein above, the Employer reserves the right to assess the capacity and capability of the bidder, should the circumstances warrant such assessment in an overall interest of the Employer. The employer reserves the right to waive minor deviations if they do not materially affect the capability of the Bidder to perform the contract.

### **For the Services/works specification:-**

#### **a. Technical Requirement:-**

- i. The bidder should have a valid Class 'A' Electrical License Holder or who have applied for the current financial year shall be considered.
- ii. The bidder should have successfully completed the turnkey/semi-turnkey work of the following nature in the last three financial year under UPPCL/PVVNL as prime contractor from the date of opening of bid part-1:-
  1. Should have successfully erected and commissioned similar of higher rating work in single turnkey/semi turnkey order, having minimum order value of 80% each of the estimated cost of the present tender specification, or
  2. Should have successfully erected and commissioned similar of higher rating work in maximum two turnkey/semi turnkey order, having minimum order value of 50% each of the estimated cost of the present tender specification, or
  3. Should have successfully erected and commissioned similar of higher rating work in maximum three turnkey/semi turnkey order, having minimum order value of 40% each of the estimated cost of the present tender specification.

#### **b. Financial Requirement :-**

- i) The **Minimum Average Annual Turnover (MAAT)** for the best Three years out of the last Five Financial years MAAT should not be less than Rs..... (150% of the estimated cost)
- ii) **Solvency** : the bidder should have a minimum solvency of Rs----- (25% of estimated cost) or credit facility for the same from Nationalized/scheduled bank.

It shall contain the tender fee, earnest money in the prescribed form shall be submitted online only on E-Tender Portal <https://etender.up.nic.in> will contain the Tender Performa, Pre-Qualification documents, Income Tax, Sales Tax clearance certificates, Technical particulars, Guarantee, Test certificate, Drawings, Literatures, Schedules of delivery and other general terms and conditions, past experience etc. shall be subscribed "TENDER BID PART-I AGAINST E-TENDER No – 116/EDC-I/B/2021-2022"
