AND OTHER RELATED WORK (SUPPLY & INSTALLATION) FOR ELECTRICITY CONNECTION OF CONSUMER M/S ADANI ENTERPRISES LTD., C-20/1A/10, SECTOR-62, NOIDA (TOTAL LOAD 81000 KVA) (FIRST PHASE 25 MVA TO BE RELEASE TILL MONTH DECEMBER 2023) IN FULL DEPOSIT SCHEME IN AREA OF EUDSD-XIII, NOIDA UNDER EUDD-VII, NOIDA IN THE JURIDICITION OF EUDC-I, NOIDA (ALL TYPE LABOUR AND MATERIAL WILL BE PROVIDING BY THE CONTRACTOR AT HIS OWN COST ON TIME).

Special Conditions of the Specification

Responsibilities of Contractor:-

1. The contractor is required to make they fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
2. The contractor shall be supplying, erecting, testing & commissioning of all materials and equipments not mentioned specifically in the scope of works but required to complete the job in all respect, except excluded specifically for which no extra payment shall be made.
3. Safety of Man & Material shall be ensured by contractor.
4. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.

Taxes:-

GST will be paid extra as per rule.

Terms & Conditions:-

1. Any loss or damage to any of the public utilities shall be repaired by the contractor at his own cost.
2. The Contractor shall have to arrange all carriage facility including transportation cartages, man power T&P etc on its own cost.
3. The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/ Loss/Accident etc of any kind and Damaged and Removed material and Spares parts will be retained by department.
4. No T&P will be provided by the department. The Contractor shall arrange all the T&Ps. Equipments. Welding set, generator set etc. required for carrying out the above work at his own cost.
5. The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts /damages/accidents etc. to the material of the PVVNL.
6. During the period of work in progress, the Contractor shall have to provide lighting arrangement sign board etc or necessary precautionary arrangement so that accident/damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
7. The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt/ PVVNL.
8. All the charges on account of damages/losses/thefts etc. involved under the condition laid down above shall be borne by the contractor.
9. Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc.

10. The contractor shall have to execute the work within the stipulated time as provided in the order to be issued by the competent authority.
11. A Penalty @ ½% per week for Delay/Late in Execution of work shall be payable by the contractor on the total value of work. The maximum penalty livable will not, however, exceed 10% of the value of the contract.
12. The Proper Shut down will be given as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
13. The work is to be done by the Contractor under the Direct Supervision of Nodal S.D.O (Dist.).
14. Agreement/Work may vary up to any extent but the face value of the agreement shall not vary beyond the (+/-) 10% of Agreement Value/any quantity of boq.
15. General Conditions of Contract Form 'A' & Form 'B' and Standard Contract Conditions of UPSEB/ UPPCL/PVVNL/SE EUDC 1 (Attached) Noida shall be integral part of tender specification.
16. Income Tax shall be deducted from the bills of the Contractor as per rules prevailing at the time of payment.
17. If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL of the Contractor.
18. The material shall be inspected by the department/ of incharge of work at manufacturer works unit/work site before supply.
19. The contractor will purchase the material as per technical specification/approved GTP.
20. The supplier of the material shall have the experience of supplying the material to PVVNL/ Govt. / PSU utilities.
21. Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
22. The Agreement can be terminated by the Engineer of the Contract at any time without any notice in the event of un-satisfactory performance of the Contractor. This is however, without prejudice to the other Terms & Conditions of the Agreement.
23. For repairing and overhauling of all the spare parts required to be replaced/repaired will be provided by the contractor and the entire repairing/overhauling work shall be carried out the site. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions.
24. 100% Supply Payment shall be released after the receipt of material and 100% Installation payment shall be released getting satisfactory report in all respect from EUTD -1, NOIDA and availability of fund by the EUTD - 1 NOIDA.
25. Any damage or loss of public property/Board's materials shall have to be borne by the contractor.
26. The material shall be inspected by the department at manufacturer works unit before supply.
27. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions
28. Employees provided by outsource agency shall in no way be considered for employment in PVVNL under any circumstances. It shall always remain the employee of the contractor.
29. Legal claims of the employees provided by contractor if any, arises at any time will be responsibility of the Contractor.
30. Contractor shall follow all the labour laws.
31. Work shall be got carried for a period mentioned in the work completion clause.

32. The Contractor shall be fully responsible for arranging accidental insurance policy for the compensation of his working personnel, if required as the Corporation shall not be help responsible for any compensation to his labour in the event of any accident/mishap whatsoever.
33. All T&P required for proper completing of assigned work, shall be arranged and provided to his labor by the Contractor himself at his own cost. However, all the required stock material/component for proper completion of work shall be arranged & provided by the Department free of cost.
34. The period of Contract under the scope of work shall be up to 45 days for the Supply of Meter and Installation within 15 days after the receipt of material or readiness of work site from the date of agreement/LOI.
35. Freight/Insurance charges, if any, shall be done by the contractor.
36. The contractor/Firm has been deposit 10% security amount in form of PBG/FDR of awarded contract value before agreement.
37. For any dispute arising out of the Contract, Chief Engineer, Noida Zone, Noida. Shall final Authority to Decide the Dispute and his Decision shall be binding on both the Parties.

Eligibility Criteria/Pre-Qualifying Requirements for Part-I

For the Services/works specification:-

a. Technical Requirement:-

- i. उपरोक्त निविदा के विशिष्टीकरण सबमिशन मीटरों के मूलनिर्माता/डीलरों द्वारा डाली गयी निविदा पर ही विचार किया जायेगा।
- ii. The bidder should have a valid G.S.T Registration. (Provide copy)
- iii. The bidder should have a valid PAN card copy. (Provide copy)
- iv. The bidder should have successfully completed the Metering testing work.
- v. The bidder should have successfully completed the similar or higher rating electrical work of the following nature in the last three financial year as prime contractor from the date of opening of bid part-1:-
 1. Should have successfully erected and commissioned similar or higher rating electrical work, having minimum order value of 80% of the estimated cost of the present tender specification,
 - or
 2. Should have successfully erected and commissioned similar or higher rating electrical work in maximum two order, having minimum order value of 50% each of the estimated cost of the present tender specification,
 - or
 3. Should have successfully erected and commissioned similar or higher rating electrical work in maximum three order, having minimum order value of 40% each of the estimated cost of the present tender specification.

b. Financial Requirement:-

- i) **The Minimum Annual Average Turnover (MAAT)** The bidder should have a minimum average annual turnover (MAAT) of Rs. 63.72 Lakh (150% of Tendered Value) per annum for the best three financial years out of the last five financial years. The audited balance sheet / CA's certificate with UDIN Number shall be enclosed in support of above failing which the bid shall not be considered.
 - ii) **Net worth** of the bidder should be positive. Net worth means the sum total of the paid up capital and free reserves (excluding reserves created out of revaluation) reduced by aggregate value of accumulated losses (including debit balance in profit and loss account for current year) and intangible assets with UDIN Number shall be enclosed in support of above failing which the bid shall not be considered.
 - iii) **Solvency:-** The bidder should have a minimum solvency of Rs. 10.62 Lakh (25% of Tendered Value) or credit facility for the same from Nationalized/scheduled bank. Certificate of Solvency must be uploaded.
- c. The bidder should not be black listed / debarred from business in any Govt. / Semi Government / PSU / Local Bodies etc. at the time of bid opening. They have to submit an undertaking on Rs. 10.00 non-judicial stamp paper with notary with date regarding this along with the bid.
