2. The price are firm and no any other charges shall be paid extra to the contractor.
3. No departmental labor and T&P shall be provided to the contractor by the department.
4. **Rates:-** The rates are to be mentioned in the schedule of quantities and no variation there on shall be allowed in any case.
5. **Penalty:-** ½% penalty per week, subject to maximum of 10% on the total face value of the agreement.
6. **Rejection of defective Works:-** Any defective/inferior quality of work not confirming to specifications, shall have to be redone by the contractor free of cost to the satisfaction of the Engineer-in-charge of the work.
7. **Earnest Money:-** Each tender must be accompanied by the Earnest money in the form of RTGS/NEFT of a scheduled Bank duly pledged in favor of Superintending Engineer, Electricity Distribution Circle, Amroha.
