Responsibilities of Contractor:-

1. The contractor is required to make them fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
2. The contractor shall be supplying, erecting, testing & commissioning of all materials and equipments not mentioned specifically in the scope of works but required to complete the job in all respect, except excluded specifically for which no extra payment shall be made.
3. The Contractor shall have to arrange all carriage facility including transportation cartages, man power, T&P etc.
4. JV's not allowed for the tender.
5. Any type of NOC (Forest Deptt., Noida/Gr.Noida/Yamuna Authority any other Govt./PSU/Private areas etc.) for the completion of following work will be arranged by the bidder itself only, Department will not be liable for these NOC.
6. Tenderes are advised to visit the sites/Areas of divisions before offering their rates.
7. Illumination/Lighting of working site shall be in the scope of contractor. Nothing shall be paid by the PVVNL.
8. Safety of Man & Material shall be ensured by contractor.
9. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.
10. Contractor shall have to deposit a security Amount @ 10% of the value of Awarded Contract in the form of FDR/PBG pledged in favor of SE EUDC-2 NOIDA and shall be returned/refunded after work completion/NOC by Concerned division.

Taxes:-

GST shall be paid Extra as per Govt. applicable rates.

Others Terms & Conditions:-

1. The Consignee of the material will be E.E. EUDD-II, Noida.
2. The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt/ PVVNL.
3. All the charges on account of damages/losses/thefts etc. involved under the condition laid down above shall be borne by the contractor.
4. Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc.
5. The charges for Road cutting, Forest Clearances charges, land lease charges or from any other agency which are required to complete the work shall be paid by the contractor, except other than items mentioned in BOQ.
6. Any loss or damage to any of the public utilities shall be replaced/repared by the contractor at his own cost.

7. The Contractor shall have to arrange all carriage facility including transportation cartages, man power T&P etc on its own cost except other than carriage mentioned in BOQ.
8. The Contractor shall make adequate Arrangement for proper Handling of Material to avoid any Damage/ Loss/Accident etc of any kind and Damaged and Removed material and Spares parts will be retained by department.
9. No T&P will be provided by the department. The Contractor shall arrange all the T&Ps. Equipments. Welding set, generator set etc. required for carrying out the above work at his own cost.
10. The contractor shall be fully responsible for any loss/thefts/damaged/accidents the material of the departments and accordingly, he shall have to keep adequate watch and ward to avoid any loss/thefts /damages/accidents etc. to the material of the PVVNL.
11. The work is to be done by the Contractor under the Direct Supervision of Nodal S.D.O (Dist.6).
12. General Conditions of Contract Form 'A' & Form 'B' and Standard Contract Conditions of UPSEB/ UPPCL/PVVNL/SE EUDC 2 Noida shall be integral part of tender specification.
13. All the spare parts required to be replaced/repaired/provided by the contractor under 12 month warranty period and the entire repairing/overhauling shall have to deposit a security Amount @ 10% of the value of Contract in the form of FDR/CDR pledged in favor of EE OF CONCRENEED DIVISON/AREA and shall be returned/refunded after 12 months warranty period.
14. Income Tax and Labour Cess shall be deducted from the bills of the Contractor as per rules prevailing of Central Govt. at the time of payment.
15. If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL of the Contractor.
16. The material shall be PVVNL GTP approved and inspected by the department at manufacturer works unit before supply. The contractor will purchase the material as per PVVNL Approved GTP.
17. During the period of work in progress, the Contractor shall have to provide lighting arrangement sign board etc or necessary precautionary arrangement so that accident/ damages/ losses to the public/ manpower of the contractor/ department etc. are avoided.
18. The contractor shall have to execute the work within the stipulated time as provided in the order issued by the competent authority.
19. A Penalty @0.5% per day for Delay/Late in Execution of work shall be payable by the contractor on the total value of contract. The maximum penalty livable will not, however, exceed 10% of the value of the order not execution.
20. Depending upon the site conditions, the individual quantity of any item /work may vary up to $\pm 20\%$ but total value of the work shall not $\pm 10\%$ exceed beyond the Agreement Value/Financial approval.
21. HDPE Pipe and other supply material by the contractor shall be inspected by the competent committee of PVVNL before supply of material for which an inspection call will be made to competent committee authority P.V.V.N.L. through S.E., E.U.D.C-II, Noida.
22. All those petty materials not appearing in the prices schedule but are required to complete the work as per Bill of Quantity / Price Schedule, shall have to be arranged by the contractor at his own cost. Similarly any work activity not specifically indicated but is required for systematic execution of job as per Bill of Quantity / Price Schedule, shall also be done by the contractor for which no separate payments shall be made.

23. Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
24. The Agreement can be terminated by the Engineer of the Contract at any time without any notice in the event of un-satisfactory performance of the Contractor. This is however, without prejudice to the other Terms & Conditions of the Agreement.
25. For repairing and overhauling of all the spare parts required to be replaced/repared will be provided by the contractor and the entire repairing/overhauling work shall be carried out the site. The work will have to be carried out strictly as per Indian Electricity Rules & RESPO specification and guidelines and relevant drawings, subject to modification as per site conditions.
