3. **Open Competitive Bidding – International** will be conducted in accordance with ADB's Single-Stage: Two-Envelope procedure and is open to all Bidders from eligible source countries as described in the Bidding Document.
4. To be qualified for the contract package, the bidder should as a minimum meet the following requirements:
  - a) Average annual construction turnover of INR 96.70 Crore calculated as total certified payments received for contracts in progress or completed, within the last 3 years.
  - b) Participation as a contractor, Joint Venture partner, or Subcontractor, in construction of HT and LT Power distribution lines and distribution transformers contract/s that have been successfully completed within the last 5 years and are similar to the proposed contract, where the value of the Bidder's participation exceeds INR 77.36 Crore for single completed contract.
  - c) Meet other financial and experience requirements as indicated in the Section 3 of the Bidding

Documents and make an informed decision on their eligibility to qualify to submission of a bid and the need to form a joint venture with another party if a Bidder does not meet the qualification criteria as a single entity.
