**Techno-commercial:** Each and every page of the tender documents submitted in this part in support of fulfilling the Pre-qualifying requirement, should be duly signed, Stamped & scanned. The scanned copy of all the techno-commercial documents are compulsorily to be uploaded on the e-procurement portal of PVVNL i.e. [www.etender.up.nic.in](http://www.etender.up.nic.in) & no hard copy of these documents are required to be submitted. Tender/Bids of firms who do not submit the techno-commercial bid along with tender Fee and EMD, **as mentioned above**, shall not be considered for price Bid Opening.

### **Technical & Financial Pre Qualifications :-**

1. The tenderer should produce experience statement showing the Name of organization, name of work, DOS, DOC, ADC, Agreement Value, Executed Value, Penalty and experience of officer with contractor during the execution of work executed in Central/State Govt. Depts. and that should not be issued by officer below class-I rank (shall be produced in Part-I).
2. Tendering firm should have experience of having successfully completed similar nature works during last 7 years ending last day of month previous to one in which applications are invited and should be either of the following (shall be produced in Part-I):-
  - A. Three similar\* completed works each costing not less than the amount equal to 40% of the estimated cost. or
  - B. Two similar\* completed works each costing not less than the amount equal to 50% of the estimated cost. or
  - C. One similar\* completed work costing not less than the amount equal to 80% of the estimated cost.

  - B- Valid character certificate issued by D.M/S.P. for partnership firm and Pvt Ltd firm Character certificate of All Directors shall be submitted. Character certificate shall be valid on date of opening of Part-1 of tender.
