 3. **The Part –I (Tender Cost +EMD) and (Techno-commercial):-**

Technical & Financial Pre Qualifications :-

Depts. and that should not be issued by officer below class-I rank (shall be produced in Part-I).
2. Tendering firm should have experience of having successfully completed similar nature works during last 7 years ending last day of month previous to one in which applications are invited and should be either of the following (shall be produced in Part-I):-
 - A. Three similar* completed works each costing not less than the amount equal to 40% of the estimated cost. or
 - B. Two similar* completed works each costing not less than the amount equal to 50% of the estimated cost. or
 - C. One similar* completed work costing not less than the amount equal to 80% of the estimated cost.

5. The tenderer should submit the following certificates in Part-I in readable form and duly signed otherwise may result in rejection of bid.
 - A- Certified & self attested copy of UTR No. & other detail for tender cost & earnest money.
 - B- Valid character certificate issued by D.M/S.P,for partnership firm and Pvt Ltd firm Character certificate of All Directors shall be submitted. Character certificate shall be valid on date of opening of Part-1 of tender.
