#### **Scope of Work:**

- 1- Shutdown procedure: - Shutdown shall be given by the Junior Engineer of concerned Sub-Station and Junior Engineer shall make sure to facilitate the same.
- 2- Attend the fault of 33 KV, 11 KV & LT line (underground & Overhead both).
- 3- Maintenance & Straightening of tilted/Damaged poles and replacement of the same.
- 4- Maintenance of 33KV, 11 KV and LT Lines.
- 5- Maintenance of Distribution Transformers & Yard.
- 6- Maintenance of Power Transformers & yard of Sub-Stations.
- 7- Due to storm / Rain at the time of emergency if any tree falls on line, same shall be removed as quickly as possible with the help of electric Saws.
- 8- Tree Chopping and Cutting with gang in the scope of Agency with providing Platform/Hand Held Machine as per site requirement with driver and fuel. Agency shall be arranged separate Gang for the Tree Cutting works.
- 9- Each break down shall be attended immediately by the Mobile Service Van with Gang on receipt of intimation from concerned divisions/Whatsapp Group.
- 10- Replacement of burnt distribution transformers in emergency from the Store/Workshop/JE Store.
- 11- Agency has to carriage all materials in emergency for attending the breakdown from the Store/Workshop/JE Store.
- 12- Any other work as per direction of concerned Nodal Officer/Concerned Executive Engineer /Superintending Engineer EUDC -2, Noida/Chief Engineer Noida Zone, Noida.
- 13- The Contractor shall have to arrange all type carriage facility including transportation cartages, manpower, T&P (Hydra, Van, Welding Machine, Tractor, Extra Gang and other required equipments/items for complete the work) etc. at own cost.

#### **Responsibilities of Contractor:-**

1. The contractor is required to make they fully conversant with the job required and the work shall be executed as per general conditions of the tender specification contract.
2. The Contractor shall have to arrange all carriage facility including transportation cartages, man power, T&P etc.
3. Any type of NOC for the completion of following work will be arranged by the Contractor itself only, Department will not be liable for these NOC.
4. Tenderes are advised to visit the sites/Areas of divisions before offering their rates.
5. Illumination/Lighting of working site shall be in the scope of contractor. Nothing shall be paid by the PVVNL.
6. Safety of Man & Material shall be ensured by contractor.
7. The contractor shall ensure that the work is carried out as per NGT Norms/Standard and in such a manner that all premises always look Neat & clean, Similarly, the waste disposal is also carried out in totally sealed manner without affecting the Environment.

#### **Taxes:-**

GST will be paid extra as per rule.

#### **OTHER TEMRS & CONDITIONS :**

These special conditions shall be read and construed along with the general conditions of contract Form-A as mentioned by the provision here of but if there by any conflict OR inconsistence between the provision here of and these mentioned in General conditions of contract From-A the provisions contained in these special conditions shall prevail.

1. **Contract rates:-**The contract rates shall be firm and firm up to the date of execution of work to the contracted value.
2. **Quantity and Rates:-**The quantity and rates thereof are mentioned in the annexed rate schedule.
3. **Security Deposit:-** The Contractor shall deposit a contract performance @ 10% of awarded contract in favor of SE EUDC 2 NOIDA. FDR will be returned/refund after twelve months only after Satisfactory Completion of work. In any case, the successful bidder shall not be allowed to deduct CPG amount from their running bills and they are required valid & requisite Contract Performance Guarantee.
4. **Period:-**The work shall commence from LOI/Agreement Date/Period mentioned in the LOI and Agreement to Six Months.
5. **Penalty:-**If the Contractor Fails to execute the work within the stipulated period, the order placing authority reserve the right to get the work done departmentally or through any other agency. The Excess expenditure, if any, incurred in this connection plus 15% supervision charges shall be debited from the Contractor and it will be recovered from the Security Amount/Running/Pending Bills or through any other credit pending with UPPCL/PVVNL of the Contractor.
6. **Supervision:-**The work shall be done under supervision of EE, EUDD-3,NOIDA is to shall nominate are concerned SDO as Nodal Officer for supervision. He shall maintain a daily record of work done by the Mobile Service Van (Gang).
7. **Tax:-Income** Tax & other Tax (Labour Cess) shall be deducted from the contractor bills as per rule.
8. The Old & Used material shall be taken into stock account by the concerned JE and the firm shall submit the details in the running bills.
9. All work record should be kept under this tender in concerned Division.
10. **Payment:-**Payment of work shall be done by EE EUDD-3 NOIDA after successful completion of work monthly basis. Measurement of work shall be insured within 10 Days by submission of bill by concerned Executive Engineer.
11. **Extension:-**The agreement can be extended to six months or as required by the PVVNL/Contract of Engineer as per mutual consent by both the parties.
12. Vehicle provided by the contractor shall have got painted it's front & sides with phone number of control room and toll free No. 1912 along with the logo of PVVNL. Vehicle should have "Emergency Electrical Service" boldly written at top of the front side in Red colour.
13. The vehicles should be duly insured and the Road-Tax etc. should be paid upto date.
14. The fuel shall be provided by the contractor himself.
15. The servicing of the vehicle/Lubricants/Repair etc. shall be the responsibility of the Contractors and the department shall not pay the charges for these activities.
16. The quantity and Agreement Value may vary  $\pm$  10% after getting Financial Approval from Competent Authority.
17. The Agency shall be deputed a Supervisor for the supervision of gang at own his cost.
18. The agency has been received feedback from consumers where work was done on a register. Register will be checked by monthly basis by the contract of engineer.
19. **Arrangement of Material:-** All consumables available in PVVNL store will be got issued by the divisions and will be replenished to the vehicle from time to time, without fail. The material not available in the PVVNL store shall have to be arranged by the zone, circle, division on local basis (as the case may be). It will be the duty of Nodal Executive Engineer to monitor the supply of material to the gang. In no case, vehicle shall remain unutilized.
20. Four days holiday shall be admissible to each member of gang in such a manner that the daily functioning of Mobile Service Van will not be effected.

**Priority decisions:-**

The complaints to the van will come through the following sources:-

- Department officials up to JE's.
- Complaints received from 1912, being redirected to the van by officials of zone.
- In case of dispute regarding priority of the work, the circle officer will have final say.

Also, it shall have to be monitored that no such work, such as line shifting, construction of new line, deposit work & 15% supervision work are allotted to the van. It will be responsibility of concerned Executive Engineer to not let that happen. The firm shall have to take the photos during the execution work and the same shall be sent to the group.

21. The contractor shall be liable to pay compensation for any accident to his workmen during execution of the work which shall be paid as per labour law as applicable.
22. The contractor will provide gang 24x7 including night shifts.
23. In case of emergency and if need arises Nodal Officer with the consent of concerned Superintending Engineer can rearrange the work force. Shift schedule will change accordingly.
24. In cases wherein permission of other government bodies of the city of the district is required, the same shall be obtained by PVVNL. Any financial burden such as payment for digging the road etc. shall be borne by the department.
25. All T&P required for proper completion of assigned work, shall be arranged and provided to his labour by the contractor himself at his own cost.
26. Safe carriage, proper stacking and fixing or installing of the material during the transit will be the responsibility of the contractor.
27. General Conditions:- The work shall be carried out as per general condition of contract Form „A“ & its addenda.
28. Arbitration Clause:- The contract shall be governed by the general conditions of the contract form 'A'. To take any action or proceedings initiated by any of the parties. The agreement shall be in the court of competent jurisdiction under the high court of Allahabad. All dispute arising out of and touching or relating to the subject matter of this agreement shall be subject to the jurisdiction of local court only.
29. The Vehicle location will be monitored by its GPS locational tool and contractor shall facilitate it in such a way that even higher ups can also watch the moment of vehicle on net.
30. Notwithstanding the agreement executed with the Contractor, the Engineer of the contract always reserves the right to get the work done by department or through any other agency. The Contractor shall have no objection and claims over such work.
31. Employees provided by outsource agency shall in no way be considered for employment in PVVNL under any circumstances. It shall always remain the employee of the contractor.
32. The Contractor will provide dress to his employees after discussion with PVVNL officers.
33. The Contractor will provide identity card & Mobile with Sim to employees.
34. Legal claims of the employees provided by contractor if any, arises at any time will be responsibility of the Contractor.
35. All rules & regulations of PVVNL/UPPCL/EUDC-2 NOIDA STANDARD CONTRACT or erstwhile UPSEB FORM ‘A’ and standard contract terms and conditions of EUDC-II, Noida shall be strictly followed by the Contractor.
36. Contractor shall follow all the labour laws.
37. The contractor shall be fully responsible for any accident/loss to the persons(s) working with/under him and shall have to pay compensation in accordance with the prevailing rules & regulations of Govt/ PVVNL.
38. All the charges on account of damages/losses/thefts etc. involved under the condition laid down above shall be borne by the contractor.
39. The contractor shall have to execute the work within the stipulated time as provided in the order issued by the competent authority/Nodal officer/Concerned Officer of PVVNL.
40. A Penalty @0.5% per day for Delay/Late in Execution of work shall be payable by the contractor on the total value of contract. The maximum penalty livable will not, however, exceed 10% of the value of the order not execution.
41. The Proper Shut down will be given as required by the Contractor time to time as per site/system Requirement and Availability by the SDO/JE of the Concern Area.
42. Proper skilled staff included Supervisor capable for execution of the above work shall have to be arranged by the contractor. The safety of labour while at work shall be the responsibility of the contractor and any compensation to be paid to them on any account, whatsoever, shall also be responsibility of the contractor UPPCL/ PVVNL shall not be liable for any such compensation etc
43. Work shall be got carried for a period mentioned in the work completion clause.
44. GST tax shall be paid extra, if legally applicable & the contractor should be registered in the GST tax department. (Self attested photo copy shall be provided.)

45. The Contractor shall be fully responsible for arranging accidental insurance policy for the compensation of his working personnel, if required as the Corporation shall not be help responsible for any compensation to his labour in the event of any accident/mishap whatsoever.
46. All T&P required for proper completing of assigned work, shall be arranged and provided to his labor by the Contractor himself at his own cost. However, all the required stock material/component for proper completion of work shall be arranged & provided by the Department free of cost.
47. The agreement can be terminated by the Superintending Engineer of the contract at any time without any notice in the event of un-satisfactory performance of the contractor. This is however, without prejudice to the other terms & conditions of the agreement.
