Section - 2

Eligibility Criteria

The bidder must possess the requisite experience, strength, and capabilities in providing services necessary to meet the requirements as described in the RFP document. Keeping in view the complexity and volume of the work involved, following criteria are prescribed as the eligibility criteria for the bidder interested in undertaking the project. The bidder must also possess technical know-how and financial wherewithal that would be required for AMC of IT Equipments of all Towns in PVVNL. The bidders must fulfill all the below criteria before their bids may be considered for opening.

The price evaluation would be based on L1, i.e., the bidder with the least price quote shall be eligible for award of contract.

PVVNL reserves the rights to negotiate and rationalize the rates quoted by the bidders. Once finalized, the bidder will abide by the rates irrespective of the rates and incentives given/offered to other service providers for the similar work.

Authority shall open the “Financial Proposal” only for the bidders who meet the pre- qualifications / eligibility requirements.

Appointment of Successful Bidder

- *Award Criteria*

1. The price evaluation would be based on L1, i.e., the bidder with the least price quote shall be eligible for award of contract.
2. The criteria for selection will be the lowest effective cost to PVVNL from eligible bidders
3. In case of lowest bidder does not accept the contract or found to be involved in corrupt and/or fraudulent practices the next lower bidder will be awarded the contract after price negotiation if needed.
4. The aforesaid clause will supersede any clause previously mentioned in the RFP for selection of the bidder.

- *Right to Accept Any Bid and to Reject Any or All Bid(s)*

PVVNL reserves the right to accept or reject any bid(s), and to annul the bidding process / Public procurement process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the affected bidder or bidders or any obligation to inform the affected bidder or bidders of the grounds for PVVNL action.

- *Notification of Award*

The PVVNL shall issue the Notice for Award or Letter of Intent/Award of the Contract to the successful bidder within the Bid Validity Period.

The successful bidder will be required to sign and submit the Contract unconditionally

The notification of award will constitute the formation of the Contract. Upon the successful Bidder's signing the contract, PVVNL will notify each unsuccessful bidder and return their EMD.

- *Modification to Contract*

The Contract, when executed by both the parties, shall constitute the entire Contract between the parties in connection with the jobs/services and shall be binding upon the parties. Modification, if any, to the contract/draft contract shall be in writing and with the consent of both the parties.

- *Signing of Contract*

The Contract shall be signed with the successful bidder, being selected for the award based on the selection criteria.

- *Failure to Agree with the Terms and Conditions of the RFP and its Contract Agreement*

Failure of the successful bidder to agree with the Draft Agreement and Terms & Conditions of the RFP shall constitute sufficient grounds for the annulment of the award, in which event PVVNL may award the contract to the next technically responsive and most economical bidder (having next best least cost) or call for new bids from the interested bidders. PVVNL shall be entitled to forfeit the EMD of the said successful bidder.

- *Compliance with Statutory Requirements*

The Bidder shall maintain complete confidentiality of the information shared by the PVVNL for facilitating the Contract and all the records, information which is generated as an end deliverable of this Contract. The strict action shall be taken against the Bidder if evidence of confidential data disclosure is found.

- *Income Tax Deduction at Source*

Income tax deduction at the source shall be made at the prescribed rates from the Bidder's invoices/bills. The deducted amount will be reflected in the requisite Form, which will be issued at the end of the financial year.

Section – 3

Scope Of Work

3.1 INTRODUCTION

Pashchimanchal Vidyut Vitran Nigam Ltd. (PVVNL) is a Govt. of Uttar Pradesh undertaking registered under the Companies Act-1956. PVVNL inherited the distribution business of erstwhile U.P State Electricity Board in UP west in pursuance to second transfer scheme notified by the Govt. of U.P.

For IT enablement, hardware equipment viz. desktops, UPS etc. have been installed at all end locations across districts, each of which equipment is now approx 06 to 08 years old.

3.2 REQUEST FOR PROPOSAL

PVVNL Meerut invites bids for selection of agency for providing AMC of End Locations IT Equipment in all offices.

3.3 SCOPE OF WORK

The objective behind this RFP is to outsource the job wise AMC services of entire IT infrastructure at end locations, which includes Desktop and UPS, other related hardware etc. as detailed in this document.

This is aimed to achieve maximum uptime of the installed Systems / Devices / Equipments for optimum utilization of resources, and availability of various equipment and services to end-users.

Further, to support end users by processing and resolving complaints in minimum possible time by taking up it at appropriate place and level thereby delivering a better uptime of the entire IT setup of the Discom.

Scope shall include two broad aspects: -

1. Preventive and Breakdown Maintenance

The Selected Vendor shall provide the following services (including but not limited to):

The successful bidder must provide services to set right the malfunctions/ non-functioning of the IT hardware installed at end locations.

The parts for which rectification could not be provided shall be replaced by the bidder. The parts that are to be replaced should be new part of reputed brand and at least equivalent in performance and capacity.

The scope of the services for overall IT infrastructure management during this period shall include continuous monitoring and preventive/proactive maintenance of the entire equipment set.

The bidder shall maintain the adequate stocks of spares to meet the SLA requirements.

Whenever a component has to be replaced because of technical, functional, manufacturing or any other problem, it shall be replaced with a new component of the same make and configuration at bidder's cost.

Quantities of IT Hardware is mentioned in Section-7 Annexure-A, installed at different end locations

Bidder must maintain the warranty of replaced hardware for atleast 1 Year. Bidders must do preventive mentinance of the asset if visit is done for fault ticket.

Generate SLA and System reports in generic or any other customized format as required by the purchaser.

SLA timelines are annexed at **Appendix N**.

3. Deliverables

Supplier shall provide all the deliverables as per the bid requirements. Following is an indicative list of deliverables: -

- a) System fault / failure analysis report along with resolution.
- b) Monthly SLA compliance report containing Status of call logged.
- c) List of Monthly Human Resources available for this AMC.

4. Maintenance Call Logging & Forwarding

IT Infrastructure Managed Services (IMS) shall cover various technical services such as support for Desktop & Laptop computers, their Operating Systems, UPS, Virus Protection, IT Asset Management, Service Desk services etc. for all the IT Systems covered under the Scope of Work.

5. Human Resource Deployment

Technically sound human resources as per eligibility criteria with proper hierarchy (For Example Project Manager, Zonal Manager, Field Support Technical Staff etc) must be available across all towns to address the complaints efficiently in satisfaction of prescribed SLAs. Dedicated Town wise resources must be locally available and properly equipped with mobile phone, laptop and internet connectivity. This list must be shared with respective Field Officers/Discom's Nodal Officers.

3.4 Period of Services

Initially services are required for a period of One year (12 Months) and period can be extended further 2 years (upto 3 Years) based on mutual consent and performance of the bidder.

3.5 Service Level Agreement (SLA):

The purpose of this SLA is to clearly define the levels of service to be provided by Supplier to Purchaser for the duration of this contract or until this SLA has been amended. The benefit of this SLA is to:

1. Trigger a process that applies Purchaser and Supplier management attention to some aspect of Performance only when that aspect drops below an agreed upon threshold, or target.
2. Makes explicit the performance related expectations on performance required by the Purchaser
3. Assist the Purchaser to control levels and performance of services provided by Supplier
4. This SLA is between Supplier and Purchaser.

Bidder required to meet SLA satisfaction as per PVVNL.

Satisfactory SLA for Priorities Level1, Level2, Level3, Level 4 must be met. Priority wise Levels are annexed at Appendix N.

3.6 Payments:

- a) The payments are subject to bidder having furnished the performance guarantee for stipulated amount, as per relevant section of the General Conditions of Contract.
- b) Invoices against each month shall be submitted by bidder upon successful completion of concerning month against which due payment shall be paid upon SLA verification.
- c) Payment will be done on actual quantity which will be covered under AMC for that month.
- d) The monthly bills (invoices) will be submitted in triplicate, duly revenue stamped, along with the following documents: -
 - i) Monthly - Consolidated record of Call reports.
 - ii) Monthly - Exception report item wise indicating all calls completed with calculation of non-performance deductions as per SLA.
 - iii) Monthly report giving details of all assets checked and verified in the month, alongwith details of pro-rata additions/ deletions.

Section – 4

Instructions to Bidders

4.1 Number of Proposals and respondents

No Bidder shall submit more than one (1) Proposal, in response to this RFP.

The RFP is non-transferable, and Proposals shall be submitted only by the respective Bidders to whom the RFP has been issued by Purchaser.

Sub-contracting is not allowed

4.2 Proposal preparation cost

The Bidders shall bear all costs associated with the preparation and submission of the Proposal.

Purchaser will not be responsible and liable for any costs, regardless of the conduct or outcome of the Proposal/process.

All papers/documents submitted with the Proposal are neither returnable nor claimable.

4.3 Cost of Bidding

The Bidder shall bear all costs associated with the preparation and submission of this Bid including pre-bid, post-bid discussions, technical and other presentations etc., and PVVNL shall in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process. The cost of all stamp duties payable for executing the RFP, Bid Documents, and Project shall be borne by the relevant Bidder.

4.4 Bid Fee:

The Bidder will have to remit a Non-refundable Bid Fee (cost of bid document) of Rs. 5,000 + GST@ 18% into official bank account of PVVNL, (account details given in this RFP) on or before the date & hours of submission of the bids.

4.5 EMD

- The Earnest Money Deposit: To be deposited vide RTGS/NEFT towards EMD of Rs 2,00,000/- (Rupees Two Lacs Only), issued by any Nationalized/Scheduled Commercial bank or online in PVVNL account valid for Six months from the due date of the tender / RFPs.
- Failure in submitting of EMD and Bid Fee online on or before given time shall lead to rejection of the bid by PVVNL as non-responsive.
- UTR details of paid Bid Fee and EMD amount shall be enclosed with technical bid document to be uploaded in Bid Part-I. Right to accept and reject any or all the Proposals
- Notwithstanding anything contained in this RFP, Purchaser reserves the right to accept or reject any Proposal and to annul the bidding process and reject all the Proposals, at any time without any liability or any obligation for such acceptance, rejection or annulment, without assigning any reason.

The EMD may be forfeited at the discretion of PVVNL, on account of one or more of the following reasons:

- a) If a Bidder withdraws their Bid during the period of Bid validity.
- b) If Bidder does not respond to requests for clarification of their Bid
- c) If Bidder fails to co-operate in the Bid evaluation process, and
- d) In case of a successful Bidder, the said Bidder fails:
 - i. To sign the Agreement / Contract in time
 - ii. To furnish Security & Performance Bank Guarantee as prescribed.
 - iii. If the bidder is found to be involved in fraudulent practices.

4.6 Purchaser reserves the right to reject any Proposal if:

At any time, a material misrepresentation is made or discovered, or

- The Bidder/s do/does not respond promptly and diligently to requests for supplemental information required for the evaluation of Proposals, or
- The Bidder must adhere to the formats provided in the RFP while furnishing the required information/details.

4.7 Clarification

- Bidders are encouraged to inform themselves fully about the assignment and the local conditions before submitting the Proposal by paying a visit to the Purchaser and the Project site, sending written queries to the Purchaser, and attending a Pre-Proposal Conference
- Bidders requiring any clarification on the RFP may send their queries to the Purchaser in writing before the date mentioned in the schedule of bidding process. The queries will be sent only by email at the mail id provided in communications details in the Data Sheet with subject clearly written the following identification:
- The Purchaser shall endeavor to respond to the queries within the period specified therein but no later than 7 (seven) days prior to the (Proposal Due Date) PDD. The responses will be sent by e-mail. The Purchaser will post the reply to all such queries on the Official Website.
- The Purchaser reserves the right not to respond to any queries or provide any clarifications, in its sole discretion, and nothing in this shall be construed as obliging the Purchaser to respond to any question or to provide any clarification.

4.8 Amendment of the RFP

- At any time prior to the Proposal Due Date (PDD), the Purchaser, for any reason, whether at its own initiative or in response to a clarification requested by eligible Bidder/s, may modify the RFP by issuance of an addendum. Such amendments shall be uploaded on the e-procurement website <http://etender.up.nic.in> through a corrigendum and form an integral part of the e-bid/Proposal document. The relevant clauses of the e-bid/Proposal document shall be treated as amended accordingly. It shall be the sole responsibility of the prospective Bidder to check the abovementioned websites from time to time for any amendment in the RFP document/s. In case of failure to get the amendments, if any, the Purchaser shall not be responsible for it.
- **In order to provide the Bidders a reasonable time to examine the addendum, or for any other reason, Purchaser may, at its own discretion, extend the Proposal Due Date.**

4.9 Data identification and collection

It is desirable that the Bidders submit their Proposal/s after verifying the availability of the data, information and/or any other matter considered relevant.

It would be deemed that by submitting the Proposal, the Bidder has:

- Made a complete and careful examination and accepted the RFP in totality;
- Received all relevant information requested from Purchaser and;
- Made a complete and careful examination of the various aspects of the Scope of Work.
- Made a complete and careful examination of the various aspects of the Scope of Work.
- Purchaser shall not be liable for any mistake or error on the part of the Bidder in respect of the above.

4.10: Contract Obligations

If after the award of the contract the bidder does not sign the Agreement or fails to furnish the Performance Bank guarantee along with the inception report and working schedule as per the bid requirements & if the operation are not started within 15 working days after submission of P.B.G. as mentioned in the bid, PVVNL reserves the right to cancel the contract and apply all remedies available under the terms and conditions of this contract.

4.11 Preparation and submission of Proposals

4.11.1 Language and currency

- The Proposal and all related correspondence and documents should be written in the English language. Supporting documents and printed literature furnished by the Bidders with the Proposal may be in any other language provided that they are accompanied by appropriate translations of the pertinent passages in the English language. Supporting materials, which are not translated into English, may not be considered for evaluation. For the purpose of interpretation and evaluation of the Proposal, the English language translation shall prevail.
- The currency for the purpose of the Proposal shall be the Indian National Rupee (INR).

4.11.2 Proposal validity period and extension

- Proposals shall remain valid for a period of One hundred & eighty days (180) from the Proposal Due Date ("Proposal Validity Period") and Purchaser may solicit the Bidder's consent for extension of the period of validity, if required. Purchaser reserves the right to reject any Proposal, which does not meet this requirement.
- In exceptional circumstances, prior to expiry of the original Proposal Validity Period, Purchaser may request Bidders to extend the validity period for specified additional period. Bidders, who may not extend the validity period, will deem to have withdrawn their Proposal at the expiry of validity period.

4.11.3 Format and signing of Proposals

- The Bidders shall prepare electronic copies of the technical and financial e-bid/Proposals separately.
- Bidders should provide all the information as per the RFP and in the specified formats. Purchaser reserves the right to reject any Proposal that is not in the specified formats.
- In case the Bidders intends to provide additional information for which specified space in the given format is not sufficient, it can be furnished in duly stamped and signed PDFs.

4.11.4 Submission of e-bid/Proposal

- The bid submission module of e-procurement website <http://etender.up.nic.in> enables the Bidders to submit the Proposal online in response to this RFP published by the Purchaser. Submission can be done till the Proposal Due Date specified in the RFP. Bidders should start the process well in advance so that they can submit their Proposal in time. The Bidder should submit their Proposal considering the server time displayed in the e-procurement website. This server time is the time by which the submission activity will be allowed on the Proposal Due Date indicated in the RFP schedule. Once the submission date and time has passed, the Bidders cannot submit their Proposals. For delay in submission of Proposal due to any reasons, the Bidders shall only be held responsible.

- The entire bid-submission would be online on NIC Portal and upload the necessary scanned documents such as bid documents etc. Broad outline of submissions are as follows:
 - (i) Submission of digitally signed copy of Tender Documents/Addendum/ addenda
 - (ii) Two Parts of Bid
 - Techno-commercial -Part
 - Bid-Annexure Financial-Part
- Bidders must ensure that all documents uploaded on e-tender Portal as files or zipped folders, contain valid files and are not corrupt or damaged due to any processing at bidder PC system like zipping etc.
- The Bidders must follow the following instructions for submission:
 - For participating through the e-tendering system, it is necessary for the Bidders to be the registered users of the e-procurement website <http://etender.up.nic.in>. The Bidders must obtain a user login ID and password by registering themselves with U.P. Electronics Corporation Ltd. (UPLC), Lucknow if they have not done so previously.
 - In addition to the normal registration, the Bidder must register with his/her Digital Signature Certificate (DSC) in the e-tendering system and subsequently he/she will be allowed to carry out his/her ebid/Proposal submission activities. Registering the DSC is a one-time activity. Before proceeding to register his/her DSC, the Bidder should first log on to the e-tendering system using the user login option on the home page with the login ID and password with which he/she has registered.
 - For successful registration of DSC on e-procurement website <http://etender.up.nic.in> the Bidder must ensure that he/she should possess class-2/class-3 DSC issued by any Certifying Authorities approved by Controller of Certifying Authorities, Government of India, as the e-procurement website <http://etender.up.nic.in> is presently accepting DSC issued by these authorities only. The Bidder can obtain user login ID and perform DSC registration exercise above even before e-bid/Proposal submission date starts. The Purchaser shall not be held responsible if the Bidder fails to submit his/her e-bid/Proposal before the Proposal Due Date due to DSC registration problem.
 - The Bidder can search for active tenders through "search active tenders" link, select a tender in which he/she is interested in and then move it to 'My Tenders' folder using the options available in the e-bid submission menu. After selecting the tender, for which the Bidder intends to e-bid/Proposal, from "My tenders" folder, the Bidder can place his/her e-bid/Proposal by clicking "pay offline" option available at the end of the view tender details form. Before this, the Bidder should download the RFP document including financial format and study them carefully. The Bidder should keep all the documents ready as per the requirements of RFP document in the PDF format.
 - After clicking the 'pay offline' option, the Bidder will be redirected to terms and conditions page. The Bidder should read the terms & condition before proceeding to fill in the Bid Processing Fee offline payment details. After entering and saving the Bid Processing Fee details form so that "Bid document preparation and submission" window appears to upload the documents as per technical and financial schedules/packets given in the tender details. The

details of the RTGS should tally with the details available in the scanned copy and the date entered during e-bid/Proposal submission time otherwise the e-bid/Proposal submitted will not be accepted.

- Before uploading, the Bidder has to select the relevant DSC. He may be prompted to enter the DSC password, if necessary. For uploading, the Bidder should click "browse" button against each document label in technical and financial schedules/packets and then upload the relevant PDF files already prepared and stored in the Bidder's computer.

- Purchaser reserves the right to cancel any or all e-bids/Proposals without assigning any reason

4.11.5 Deadline for submission

- E-bid/Proposal (technical and financial) must be submitted by the Bidder at e-procurement website <http://etender.up.nic> no later than the time specified on the Proposal Due Date. The Purchaser may, at its discretion, extend this deadline for submission of Proposal by amending the RFP document, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline will thereafter be subject to the deadline, as extended.

4.11.6 Late submission

- The server time indicated in the bid management window on the e-procurement website <http://etender.up.nic.in> will be the time by which the e-bid/Proposal submission activity will be allowed till the permissible date and time scheduled in the e-tender. Once the e-bid/Proposal submission date and time is over, the Bidder cannot submit his/her e-bid/Proposal. Bidder has to start the bid submission well in advance so that the submission process passes off smoothly. The Bidder will only be held responsible if his/her e-bid/Proposal is not submitted in time due to any of his/her problems/faults, for whatsoever reason, during the e-bid/Proposal submission process.

4.11.7 Withdrawal and resubmission of Proposal

- At any point of time, a Bidder can withdraw his/her Proposal submitted online before the Proposal Due Date. For withdrawing, the Bidder should first log in using his/her login ID and password and subsequently by his/her DSC on the e-procurement website <http://etender.up.nic.in> The Bidder should then select "My bids" option in the bid submission menu. The page listing all the bids submitted by the Bidder will be displayed. Click "View" to see the details of the bid to be withdrawn. After selecting the "bid withdrawal" option, the Bidder has to click "Yes" to the message- "Do you want to withdraw this bid?" displayed in the bid information window for the selected bid. The Bidder also has to enter the bid withdrawing reasons and upload the letter giving the reasons for withdrawing before clicking the "Submit" button. The Bidder

has to confirm again by pressing "OK" button before finally withdrawing his/her selected e-bid/Proposal.

- No e-bid/Proposal may be withdrawn in the interval between the Proposal Due Date and the Proposal Validity Period. Withdrawal of an e-bid/Proposal during this interval may result in the Bidder's forfeited of his/her e-bid/Proposal security.
- The Bidder can re-submit his/her e-bid/Proposal as when required till the e-bid submission end date and time. The e-bid/Proposal submitted earlier will be replaced by the new one. The payment made by the Bidder earlier will be used for revised e-bid and the new e-bid submission summary generated after the successful submission of the revised e-bid will considered for evaluation purposes. For resubmission, the Bidder should first log in using his/her login Id and password and subsequently by his/her digital signature certificate on the e-procurement website <http://etender.up.nic.in>. The Bidder should then select "My bids" option in the bid submission menu. The page listing all the bids submitted by the Bidder will be displayed. Click "View" to see the detail of the e-bid to be resubmitted. After selecting the "bid resubmission" option, click "Encrypt & upload" to upload the revised e-bids documents.
- The Bidder can submit their revised e-bids/Proposals as many times as possible by uploading their e-bid documents within the scheduled date & time for submission of e-bids/Proposals.
- No e-bid can be resubmitted subsequently after the deadline for submission of e-bids.

4.11.8 Selection of the Agency

- From the time the Proposals are opened to the time the contract is awarded, if any Bidder wishes to contact the Purchaser, on any matter related to their Proposal it should do so in writing. Any effort by the Bidders to influence any officer or bearer of the Purchaser in the Proposal evaluation or contract award decisions may result in the rejection of the Bidder's Proposal.

4.11.9 Proposal opening

- After the technical evaluation, the Purchaser shall prepare a list of prequalified Bidders in terms of Clause 3.2 and 3.3 for opening of their financial bid. Before opening of the Financial Bid, the list of pre-qualified Bidders will be updated on etender website. Post that, the opening of Financial Bid shall be done. The Purchaser will not entertain any query or clarification from Bidder who fail to qualify at any stage of the selection process.
- Bidders are advised that selection shall be entirely at the discretion of the Purchaser. Bidders shall be deemed to have understood and agreed that the Purchaser shall not be required to provide any explanation or justification in respect of any aspect of the selection process.
- Any information contained in the Proposal shall not in any way be construed as binding on the Purchaser, its agents, successors or assigns, but shall be binding against the Bidder if the service is subsequently awarded to it.

4.11.10 Opening of Proposals

- The Bidder who is participating in e-bid/Proposal should ensure that Bid Processing Fee and EMD must be submitted in the prescribed format as specified in the RFP within the duration (strictly within opening & closing date and time of individual e-bid/Proposal) of the work as mentioned in RFP, otherwise, in any case, bid shall be rejected.
- The Bidders names and the presence or absence of requisite e-bid/Proposal security and such other details as the Purchaser at its discretion may consider appropriate, will

be notified at the opening. The names of such Bidders not meeting the technical specifications and qualification requirement shall be notified subsequently.

- The Purchaser will prepare minutes of e-bid/Proposal opening.
- Confidentiality information relating to the examination, clarification, evaluation and recommendation for the Shortlisted Agency shall not be disclosed to any person not officially concerned with the process.
- After opening of the Proposals, no information relating to the examination, clarification, evaluation and comparison of Proposals and recommendations concerning the award of contract shall be disclosed to Bidders or their representatives, if any. Any effort by a Bidder to exert undue or unfair influence in the process of examination, clarification, evaluation and comparison of Proposal/s shall result in outright rejection of the offer, made by the said Bidder.

4.11.11 Tests of responsiveness

- Prior to evaluation of the Proposals, Purchaser will determine whether each Proposal is responsive to the requirements of the RFP. The Proposals shall be considered responsive if:
 - It is received or deemed to be received by the due date and time including any extension thereof pursuant to the Data Sheet.
 - It contains all information as desired in this RFP.
 - Information is provided as per the formats specified in the RFP.
 - It mentions the validity period as set out in the “Data Sheet”.
 - Bids are accompanied with non-refundable Bid Processing Fee as stated in the Data Sheet.
 - The selected Bidder shall furnish a Performance Guarantee at the time of contract signing amounting to 10% of the total contract value in form of Bank Guarantee (BG), which should be valid for 6 months beyond the contract period. The BG shall be returned or extended after the expiry of the contract period as the case may be. The BG can be from any Nationalised or Scheduled bank.
- Purchaser reserves the right to reject any Proposal which is non-responsive and no request for alteration, modification, substitution or withdrawal shall be entertained by Purchaser in respect of such Proposal.

4.11.12 Clarifications sought by Purchaser

- To assist in the process of evaluation of Proposals, Purchaser may, at its sole discretion, ask any Bidder for clarification on its Proposal. The request for clarification and the response shall be in writing. No change in the substance of the Proposal would be permitted by way of such clarifications.

4.11.13 Proposal evaluation

- Only Shortlisted Bidders who have been found eligible under Clause 3.2 will be taken up for Financial and Technical Evaluation
- Submissions from Bidders would first be checked for responsiveness. All Proposals found to be substantially responsive shall be evaluated as per the Technical/Evaluation Criteria set out in this RFP.
- The Proposal containing the Technical Details of the Bidder/s who do not meet the Technical Criteria shall not be considered for further process.

4.11.14 Notifications

- Purchaser will notify the successful Bidder by letter.

4.11.15 Force Majeure

- Force Majeure shall mean any event or circumstances or combination of events or circumstances that materially and adversely affects, prevents or delays any Party in performance of its obligation in accordance with the terms of the Agreement, but only if and to the extent that such events and circumstances are not within the affected party's reasonable control, directly or indirectly, and effects of which could have prevented through Good Industry Practice or, in the case of construction activities through reasonable skill and care, including through the expenditure of reasonable sums of Money. Any events or circumstances meeting the description of the Force Majeure which have same effect upon the performance of any contractor shall constitute Force Majeure with respect to the Bidder. The Parties shall ensure compliance of the terms of the Agreement unless affected by the Force Majeure Events. The Bidder shall not be liable for forfeiture of its implementation / Security deposit, levy of Penalties, or termination for default if and to the extent that its delay in performance or other failure to perform its obligations under the Agreement is the result of Force Majeure.
- Force Majeure Events: The Force Majeure circumstances and events shall include the following events to the extent that such events or their consequences (it being understood that if a causing event is within the reasonable control of the affected party, the direct consequences shall also be deemed to be within such party's reasonable control) satisfy the definition as stated above.
- Without limitation to the generality of the foregoing, Force Majeure Event shall include following events and circumstances and their effects to the extent that they, or their effects, satisfy the above requirements:
 - Natural events (“Natural Events”) to the extent they satisfy the foregoing requirements including:
 - I. Any material effect on the natural elements, including lightning, fire, earthquake, cyclone, flood, storm, tornado, or typhoon;
 - II. Explosion or chemical contamination (other than resulting from an act of war);
 - III. Epidemic such as plague;
 - IV. Any event or circumstance of a nature analogous to any of the foregoing
 - Other Events (“Political Events”) to the extent that they satisfy the foregoing requirements including:
- Political Events which occur inside or Outside the State of UP or involve directly the State Government and the Central Government (“Direct Political Event”), including:
 - I. Act of war (whether declared or undeclared), invasion, armed conflict or act of foreign enemy, blockade, embargo, revolution, riot, insurrection, civil commotion, act of terrorism or sabotage;
 - II. Strikes, work to rules, go-slows which are widespread, nation-wide, or state-wide and are of political nature;

III. Any event or circumstance of a nature analogous to any of the foregoing.

4.11.16 Force Majeure Exclusions

- Force Majeure shall not include the following event(s) and/or circumstances, except to the extent that they are consequences of an event of Force Majeure:
 - I. Unavailability, late delivery
 - II. Delay in the performance of any contractor, sub-contractors or their agents

4.11.17 Contract Obligations

- Once a contract is confirmed and signed, the terms and conditions contained therein shall take precedence over the Bidder's bid and all previous correspondence.

4.11.18 Amendment to the Agreement

- Amendments to the Agreement may be made by mutual agreement by both the Parties. No variation in or modification in the terms of the Agreement shall be made except by written amendment signed by both the parties. All alterations and changes in the Agreement will consider prevailing rules, regulations and laws.

4.11.19 Use of Agreement Documents and Information

- The Bidder shall not without prior written consent from PVVNL disclose the Agreement or any provision thereof or any specification, plans, drawings, pattern, samples or information furnished by or on behalf of PVVNL in connection
- There with to any person other than the person employed by the Bidder in the performance of the Agreement. Disclosure to any such employee shall be made in confidence and shall extend only as far as may be necessary for such performance.
- The Bidder shall not without prior written consent of PVVNL make use of any document or information made available for the project except for purposes of performing the Agreement.
- All project related documents issued by PVVNL other than the Agreement itself shall remain the property of GoUP and Originals and all copies shall be returned to GoI on completion of the Bidder's performance under the Agreement, if so required by the PVVNL.

4.11.20 Performance Bank Guarantee

- The successful bidder shall at the time of award of contract, be required to provide a Performance Bank Guarantee amounting to 3% of the total contract value in the form of RTGS/NEFT/BG (from a scheduled bank) only.
- This PBG shall carry validity for the full period of contract with an extended claim period of six months. Failure on part of the contractor in submitting the PBG shall lead to stoppage of all due payments to the contractor.

4.11.21 Taxes and Duties

- Quoted Price of Financial bid must be inclusive of all taxes and duties with the exception of GST. GST shall be paid upon the applicable rates at the time of invoicing as per actuals.

4.11.22 Books and Records

- The Bidder shall not assign, in whole or in part, its rights and obligations to perform under the Agreement to a third party, except with the prior written consent from PVVNL.

4.11.24 Ownership

- All application software, hardware, data, plans, drawings, specifications, designs, reports and other documents procured or developed by the selected Vendor in the execution of the contract shall remain the property of the PVVNL, right from the beginning of the contract, during the whole duration of the project and after the expiry or termination of the contract. The PVVNL shall also remain the sole owner of the property (Hardware/software) in case the contract is terminated for any other reasons.

4.11.25 Limitation of Liability

- Except in cases of gross negligence or wilful misconduct neither Party shall be liable to the other Party for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the Contractor to pay liquidated damages to PVVNL; and the aggregate liability of the Contractor to PVVNL, whether under the Contract, in tort, or otherwise, shall not exceed the amount specified in the Contract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the contractor to indemnify PVVNL in respect to patent infringement if any.

4.11.26 Resolution of Disputes

- If any dispute, difference or controversy shall at any time arise between the Contractor on the one hand and the PVVNL and the Engineer of the Contract on the other hand Contract, or as the true construction, meaning and intent of any part or condition of the same or as to manner of execution or as to the quality or description of or the payment for the same, or as to the true intent, meaning, interpretation construction or effect of the clause of the contract specification or drawing or any of them or as to anything to be, done committed or suffered in pursuance of the contract or specification, or as in the mode of carrying the contract into effect or as to the breach or alleged breach or as to obviating or compensation for the commission any of such breach or as to any other matter or thing whatsoever connected with or arising out of the contract, and whether before or during the progress or after the completion of the contract such question, difference or dispute shall be referred for adjudication to the PVVNL or any other person nominated by him on this behalf and his decision on writing shall be final binding and conclusive. This submission shall be deemed to be a submission to arbitration modification thereof. The arbitrator may from time to time with consent of the parties, enlarge the time for making and publishing the award.
- Upon every or any such reference, the costs of an incidental to the reference and award respectively shall be at the discretion of the arbitrator, who shall be competent to determine the amount thereof or direct the same to be taxed as between solicitor and client or as between party and party and to direct by whom in what manner the same shall be borne and paid.
- Work under the contractor shall, if reasonable, continue during the arbitration proceedings and no payment due or payable by the corporation shall be withheld on account of such proceeding. In case of refusal/neglect by such nominee PVVNL may nominate another person in his place.
- Upon every or any such reference, the costs of an incidental to the reference and award respectively shall be at the discretion of the arbitrator, who shall be competent to determine the amount thereof or direct the same to be taxed as between solicitor and client or as between party and party and to direct by whom in what manner the same shall be borne and paid.
- Work under the contractor shall, if reasonable, continue during the arbitration proceedings and no payment due or payable by the corporation shall be withheld on account of such proceeding. In case of refusal/neglect by such nominee PVVNL may

nominate another person in his place.

- The place of the arbitration shall be Lucknow, UP.
- The Arbitration proceeding shall be governed by the Arbitration and Conciliation Act of 1996 as amended.
- The proceedings of arbitration shall be in English language.
- The arbitrator's award shall be substantiated in writing. The arbitration tribunal shall also decide on the costs of the arbitration procedure. The Parties hereto shall submit to the arbitrator's award and the award shall be enforceable in any competent court of law.

4.11.27 Variation in quantity of Material/Equipment/Services

- The evaluation shall be made on the overall cost of items, quantities mentioned in the RFP. Quantities of each item can be varied within contract value limit. However, PVVNL reserves the right to modify the +/-50% of the total contract value with the unit rates unaltered. If PVVNL decides to procure less than the quantity mentioned in the RFP, he will pay less the cost of such decreased quantity price and vice-versa.
