1. **Tender Bid Part-I:-** Shall contain the details of **Tender Cost, Earnest Money Deposited, Experience, Techno Commercial Particulars and other relevant documents with respect to pre-qualification conditions and to be submitted in the prescribed form.** The required documents of this part shall be uploaded online at E-Tender Portal (<https://etender.up.nic.in>) in pdf/jpg format.
2. **Tender Bid Part-II:-** Shall contain the price Bid/ Rate Schedule which is to be uploaded online only at E-Tender Portal (<https://etender.up.nic.in>) in duly filled-in excel format and need not to be submitted in physical form.
3. Tenderers are advised to scan the documents of Part-I from original/ legible copy. Tenderers have to show the original document in case of any doubt for verification/ validation purpose.
4. In case of any inconsistency of the provisions of Form A/B the provision under special Condition of Tender/Instructions to Tenderers will supersede /prevail. Please note that in Form A/B term "UP State Electricity Board" may be read as "P.V.V.N. Ltd."
5. Only such firms shall submit tender who are either reputed Manufacturers/Contractors of tendered items/works or their accredited agents or others having sufficient experience of the same nature of work and can produce satisfactory evidence that they have necessary resources and organization to undertake the work tendered for to the satisfaction of tendering authority.
6. Any portion of the terms and conditions as laid down in the Form A/B or Special Conditions etc. of tender enclosed herewith which is not clear to tenderer, should be got clarified before submission of the tender.

The specification/special conditions shall be read and construed along with annexed general conditions stipulated in PVVNL standard form 'A' as modified by provision hereunder, but if there is any conflict or inconsistency between the provisions hereunder and those contained in these special conditions shall prevail:-

1. **TENDER BID PART-I:** Shall contain the following:-

1.1 **Tender Fee:** - Tenderers are required to deposit prescribed amount towards tender cost in prescribed bank account only either by online transfer / R.T.G.S / N.E.F.T. or any other mode of digital payment and proof of payment i.e. the pay-in-slip or U.T.R. number or any other reference number shall have to be uploaded along with other documents in tender bid part-I. Details of bank account along with IFS Code are annexed herewith. The Tender fee once deposited shall not be refunded/adjusted under any circumstances, whatsoever.

1.2 **Earnest Money Deposited:** - Tenderers are required to deposit prescribed amount towards earnest money in prescribed bank account only either by online transfer/R.T.G.S / N.E.F.T. or any other mode of digital payment and proof of payment. i.e. the pay-in-slip or U.T.R. number or any other reference number shall have to be uploaded along with other documents in tender bid part-I, details of bank account along with IFS code are annexed herewith. 2. **SCOPE OF WORK :**

Carriage of Steel material from M/s Steel Authority of India Ltd., Ghaziabad to various Electricity Store Centers/Sub Centers under the jurisdiction of PVVNL Meerut including unloading and Proper stacking.

3. **RATES :**

The tenderer/contractor should quote rates only in attached proforma for rate schedule in figures and words both. All cutting and overwriting should be duly imitated. The rates should be firm in all respects.

If requirement of crane is considered necessary, the contractor/tender should include crane charges in the rates, No facility of crane charges will be provided by the department and no extra charges shall be paid to contractor on this account.

4. **TENDER BID PART-II:** - The tenderers have to quote/submit the prices only at E-Tender Portal (<https://etender.nic.in>) hence there is no need to submit price bid in hard copy.

5. **PRICES :** Quoted prices shall remain "FIRM & FIRM" in all respect exclusive of GST throughout the currency of the contract/ agreement.

6. **TAXES :** The rates should be quoted exclusive of GST.

7. **SECURITY DEPOSIT:**

The successful tenderer/contractor will be required to deposit security equal to 10% of the total value of the work for faithful performance of the work before execution of agreement in the form of FDR duly pledged in favour of Executive Engineer, Electricity Stores Division, Ghaziabad issued by any Indian Nationalized Bank.

Bank guarantee in favour of Executive Engineer, Electricity Store Division, Ghaziabad of the concerned town as per the Performa to be provided by PVVNL. The BG shall be valid till completion of contracted period along with extra 6 months as claim period. The performance security shall be refunded to the contractor after 6 months of completion of the contract as per the Agreement. The bidder has to first furnish the performance security amount and then commence work. Failure in furnishing the performance security shall result in annulment of the award and forfeiture of the earnest money.

8. **NON ADDITIONAL CHARGES:**

The tenderer/contractor will have to arrange himself all T&P required. However arrangements, if considered necessary, at the cost of the contractor and if requested by him due to any abnormal conditions that may be at sole of discretion of the Executive Engineer and the contractor shall not claim any right for such assistance from department.

9. **COMPLETION OF WORK:**

The contractor/tenderer will have to execute the work within three days time as provided in the order (Work Slip) to be issued by the Assistant Engineer, Electricity Stores Centers or his Authorized Representative. The date of receipt of the order shall be the date of the dispatch of the order by the Assistant Engineer or his representative as may be notified by the contractor on the date.

10. **WORK EXPERIENCE:**

The contractor should check the steel before loading/unloading the same, it will be presumed that the steel were in good and sound condition. The work is to be done without damage, if any, shall be debited to the contractor without any dispute and recovery of the same shall be made from their pending bill/security. The damage steel will be the property of PVVNL, Meerut.

11. **PAYMENT:**

Monthly bills shall be required to be submitted by the firm in Office of Electricity Store Division Ghaziabad within seven days after completion of the month & 100% payment shall be made by CPC Cell PVVNL H.Q. Meerut after deductions of taxes/penalties as per rules. as per availability of funds.

12. **PENALTY:**

Penalty @ Rs. 5000 per day for delay in execution of work or if vehicle not provided by the contractor for the related work, shall be payable by the contractor upto the maximum of Rs. 30,000/-.

13. **SPLITTING OF ORDER:-**

The Purchaser reserves the right to split the order among various successful tenderers in any manner he choose without assigning any reasons what so-ever.

14. **SAFETY OF MATERIAL/EQUIPMENT DURING TRANSIT:-**

The contractor should check the material/equipment before execution of work to satisfy himself that the material being taken over by him is in good and sound condition. He should immediately bring in the notice of the Engineer of the contract, the fact, in case the material is not found in good and sound condition. Otherwise it will be presumed that he has taken the material/equipment in good and sound condition.

The work is to be carried out without any damage and loss, shortage of the material during loading at site/place transit journeys by carrier, shifting and unloading at Store/places Cost as fixed by the department, in respect of damage/shortage if any, shall be debited to the contractor without any dispute and recovery shall be made from their pending bills/security and against custody of material to be given for transportation. The damaged material will be the property of the Corporation and the contractor will be paid for the journeys performed, if any on this account.

15. **LEFT OVER WORK:-**

If the contractor fails to execute the work within the stipulated period, the order placing authority reserves the right to get the work executed by any other agency. The excess expenditure, if any incurred in this connection plus 15% supervision charges shall be debitable to the contractor and recoverable from the security amount or any running/pending bill(s) or through any other credit of the contractor available with the PVVNL.

16. **WORK THROUGH OTHER AGENCY:-**

Notwithstanding the agreement executed with the contractor, the Engineer of the contract always reserves the right to get the work done departmentally or through any other agency. The contractor shall have no objection and claim over such work.

17. **CONTRACTOR'S REPRESENTATIVE:-**

The contractor will depute his authorized representative at all concerned stores/places for getting the orders from Engineer of the contract/his authorized representative. The names of authorized representatives and their local addresses shall be intimated by the contractor to the engineer of the contract within one week from the date of execution of agreement. The contractor will intimate to the Engineer of the contract changes, if any, in the local address of contractor's representative immediately on occurrence of such changes. The responsibility for non-receipt of intimation due to change in address will lie on the contractor.

18. **SUBLETTING OF THE CONTRACT:-**

The contractor shall not assign or sublet the contract/work to any other party/person without prior written approval from the Engineer of the Contract.

19. **WORKING HOURS:-**

The Contractor will be required to carry out the work assigned to him in the stores premises only during normal working hours i.e. between 8 hours to 17 hours and will not normally be allowed to work inside the store beyond these hours except under extraordinary conditions for which written permission of A.E./S.K. in charge of stores will be necessary. No claim shall be entertained by the purchaser for detention of vehicle in the stores after working hours on this account.

20. **CHARGES FOR CARRYING DEPARTMENTAL EMPLOYEE:-**

The contractor shall have to carry free of charge/obligation any department employee which in the interest of work is ordered or is considered necessary by the engineer or his authorized representative to accompany any consignment during transport in the vehicle concerned.

21. **PROVISIONS OF LABOUR LAW:-**

In every case in which by virtue or provisions of labour laws in force in the state of Uttar Pradesh & rules and regulations made there under, the corporation is required to make any payment or incur any expenditure in connection with the work executed by the contractor, the same shall be recovered from the contractor without prejudice to the other rights of the corporation by deducting it either from the security money deposits by the contractor or from his credits lying with the corporation whether under this contract or otherwise.

22. **INSOLVENCY.OFFERS.BRIBES OR GIFTS ETC.**

Either contractor does or attempts to do so or becomes involvement or commences any insolvency proceedings or attempts to make any composition with creditors and if they or any of his servant or agents either directly or indirectly give offers or bribes, gratuity, gifts, loan, perquisites, rewards or advantage, pecuniary or otherwise to any officer or person in the employment of the Corporation in any way relating to the office or employment of purchaser, the Engineer of the contract. The same consequences shall if the contract has been under clause-24 of Form-'A' and in addition the contractor shall not be entitled to recover paid for any work thereof actually performed under this contract.

23. **RATE FOR WORK NOT COVERED UNDER THIS AGREEMENT:-**
All special works for which rates have not been specified in the agreement and do not come under the preview of this contract, may be decided mutually between the contractor and the Engineer of the contract. If subsequently desired so the Engineer of the contract is free to get work done by any other agency.
24. **DEDUCTION OF G.S.T.:-**
Income tax deduction shall be made from the bills etc. of the contractor as per rules in force at the time of payment.
25. **COMPENSATION AGAINST ACCIDENTS:**
The contractor shall be fully responsible for the payment of total value of the compensation on account of any accident/damage which occurs during the work including third part risk/claim. The Engineer shall have full right for recovery against such claims/compensation from the contractor.
26. **ARBITRATION/SETTLEMENT OF DISPUTE:**
In case of any dispute arises in between the contractor and the Engineer of contract, the decision of MD, PVVNL, Meerut will be final and binding on both. All legal dispute will be under jurisdiction of Hon'ble High Court of Allahabad, U.P.
27. If at any moment any conflict arises between general conditions erstwhile UPSEB form 'A' all special condition of this tender, the special conditions (mentioned here) shall prevail
28. **TERMINATION OF AGREEMENT:**
(i) The Engineer of the contract can terminate the agreement at any time by giving one months notice in the event of unsatisfactory performance of the contractor. This is however without prejudice to the other terms and conditions of the agreement.
(ii) Contractor/contractor- representative/workers shall not demand anything in kind or cash from the consumers in lieu of work. If such evidences are found then agreement will be terminated without any notice & other legal action will also be taken.
(iii) On evidences of theft / misuse of transformer oil/materials of department by contractor/person engaged by the contractor. Contract/Agreement will be terminated without any notice and legal action shall also be taken.
(iv) In addition to penalty as mentioned in penalty clause repeated failure of contractor to store Material and transformer to Store center/site within time will lead to termination of contract.
29. **CHANGE OF TRUCK ROUTE:-**
If becomes necessary to change the route due to change in transport agency or changes due to any other reason whatsoever, intimation will have to be telephonically given by the contractor from the places of such occurrence, to the Engineer of the contract
30. **VALIDITY:**
The tender should be valid for one year (For current financial year) the rates will remain firm.
31. Comparison of rates and value of the work shall be calculated jointly and separately.
32. **VARIATION IN QUANTITIES:**
(1) The quantity covered under agreement can vary to any extent in any slab.
(2) Total quantity covered under agreement may vary ($\pm 50\%$) on either sides.

33. **PERIOD OF AGREEMENT:**
